66 Informational Reports

67 Board President’s Report:

➤ Mr. McDonald informed the Board he had the privilege of introducing the Central  
69 Middle School “Shere Kahn” group at the Music Educators Conference at Lake of  
70 the Ozark. He congratulated the group on their excellent performance and the honor  
71 of being asked to perform at the function.

➤ Mr. McDonald also stated he and Dr. Trautwein were on the Facilities Planning  
73 Committee and invited the community to attend and participate in the meetings  
74 coming up on March 2, 2009 at Central Junior High School at 6:00 p.m.; March 5 at  
75 Jefferson Elementary School at 6:00 p.m.; and on March 9 at Blanchard Elementary  
76 School at 6:00 p.m. Information concerning the Facilities Planning Committee can

79 Superintendent’s Report:

80

➤ Dr. Welker announced that the district had five (5) inclement weather days and these  
81 days would be made up at the end of the school year as indicated on the district  
82 calendar. However, the graduation date for the high school would remain the same  
83 as planned.

➤ Dr. Welker stated he had attended the Facilities Planning Committee meeting and  
85 was pleased that community members were also providing input into the district  
86 facilities plan.

87

➤ Dr. Welker reported he had attended the MSBA Legislative Forum in Jefferson City  
88 on February 16 and 17. Dr. Welker reported the legislators are still in support of  
89 fully funding the formula for the district.

90

➤ On Tuesday, February 24<sup>th</sup> at 7:00 a.m., Dr. Welker will attend a meeting of the  
91 United Way Educational Solution Committee which will be addressing the graduation  
92 rate.

➤ Dr. Welker reminded everyone that the District’s basketball tournaments are coming  
94 up and encouraged everyone to attend the games and support our students and staff.

➤ Dr. Welker reported names of the Wrestling Team members that participated and  
96 qualified for the State Wrestling Meet.

➤ Dr. Welker also read the names of the Lady Tigers Swim Team who also participated  
98 and qualified for the State Swim Meet.

100 CTA Organization:

101 Ms. Lesa Hinton reported Missouri State Teachers’ Association hosted Capitol Day for the  
102 Southeast Region CTAs on February 10. Pete Frazier, Becky Ledbetter, Pat Renard, and  
103 Ms. Hinton spoke with Senator Jason Crowell and Representatives Clint Tracy & Scott  
104 Lipke as well as other area representatives.

105 MSTAs legislative priorities for 2009 are:

•full funding of the foundation formula

•all money from Proposition A going to education

•using an earnings limit instead of number of hours a retiree may work

•local School Boards adopting a policy for Professional Negotiations

114 **Treasurer's Report**

- 115 ➤ Ms. Misty Clifton presented a Treasurer's report, which included the district's  
116 revenue and expenses to date, transfers, and ending fund balance of January 31, 2009  
117 of \$33,699,930.74 with an unrestricted fund balance of \$ 19,475,560.34.
- 118 ➤ Ms. Clifton's report also included District investments and balances and monthly  
119 expenditures summary.

121 **Board Reports:**

122 **Legislative and MSBAR Report:**

- 123 ➤ Dr. Trautwein provided handouts for Board members and anyone in the audience  
124 wanting one, of a summary of the legislative report from MSBA's "Legislative  
125 Voice", 2/2009. He highlighted items from HJR 23, HB 236, HB 682, SB 345, SB 291,  
126 SB 116, SB 373, and the Federal Stimulus Package's Impact of Funding.

128 **Cape Public School Foundation:**

- 129 ➤ Ms. Kinder reported the annual Penguin Party was a success and thanked anyone  
130 who participated and sponsored items. The Foundation raised approximately  
131 \$18,000 which will be applied to teaching grants.
- 132 ➤ Ms. Kinder announced the annual Foundation Golf Tournament at the Cape Country  
133 Club would be coming up on June 1, 2009. She encouraged everyone to participate  
134 and support the Foundation and the District.

144 **Business Items:**

145 Dr. Welker briefly reviewed the following Board policies being presented to the Board for  
146 first reading. The Board Policies are DB, DBD (rescind), DLB, EEA, EEAC (rescind), EEAD  
147 (rescind), EEAG (rescind), EFB, GCPB, GDPB (Version I), and IGAEA. No action was  
148 taken by the Board at this time.

150 **Information and Proposals from Board Members**

151 Mr. Nenninger presented a business plan form that he would like to encourage the  
152 administration to follow when organizing proposals and recommendation to the Board in the  
153 future. This plan will be looked at again at a later date. No action was taken by the Board.

154

155 Mr. Smee reported that when he had attend the MSBA Region 13 Leadership Committee  
156 meeting, the committee reviewed student's applications for scholarship through the  
157 organization. Mr. Smee noted that there were no applications from Cape Pubic School  
158 students and wondered if students had been informed of the opportunity to apply for the  
159 scholarships.

160  
161

161 At 6:58 p.m. a motion was made by Mr. Smee and seconded by Ms. Sparkman to adjourn  
162 into executive session to consider Legal Purposes, Individually Identifiable Personnel/Student  
163 Records, Employment, Personnel Evaluation, discussions of work product, and Real Estate.

164 Authority is Section 610.021, Para, 2, 3, 9 and 13, Revised Statutes of Missouri, as amended.
