47 Information, Proposals or Comments from the Audience

48 Mr. McDonald asked if there were any comments from the public and there were none.

50 Dr. Welker noted that United Way and Community Caring Council have been working on an
51 Education Solutions Team with the district and thanked Nancy Jernigan (UW) and Tom Davisson
52 (CCC) for being at the meeting. He introduced Nancy Jernigan and she thanked the Board for the
53 opportunity to speak and also thanked them for their service to the community. Ms. Jernigan

54 explained that United Way is working toward becoming an organization with community impact
55 and education is one of the root areas that impacts communities. They want to have a greater
56 impact on assisting students in graduating from high school. The Educational Solutions Team has
57 created a list of very fundamental sound research based strategies. Ms. Jernigan gave handouts to
58 Board members and asked them to look over the list and make sure they are not missing anything.
59 She said the plans are to define these further, develop a timeline and set priorities on which to
60 implement first. They want all sectors of the community, including churches and businesses, to be
61 involved in implementation. They would like the Board's approval as well as their input.

63 Mr. Tom Davisson with Community Caring Council spoke about the need for this to be a
64 community effort and encouraged Board members to attend the Coalition for Community Schools
65 Conference on March 19 at Glen Auditorium on Southeast Missouri State University's campus.

67 Dr. Welker thanked Ms. Jernigan and Mr. Davisson for attending the meeting and sharing with the
68 Board.

- 72 ➤ Mr. McDonald announced that the Board voted in closed session last month to extend Dr.
73 Welker's contract for an additional year, through June, 2012.
